INTERVENTIONIST

DEFINITION:

The Interventionist is a master teacher of core content area who works specifically with students who require intensive intervention. The goal of the interventionist is to effectively close the gap in core content area and to ensure that students return to grade level curriculum as quickly as possible.

REPORTS TO: Building Principal

ESSENTIAL FUNCTIONS:

TASKS:

Demonstrate knowledge and understanding of scientifically based reading research (SBRR) and scientifically based reading instruction (SBRI).

Understand core area programs and intervention programs and serve as a guide to the staff to effectively use these programs.

Design effective intervention lessons to accelerate student learning.

Create and manage flexible intervention groups that are based on data.

Facilitate daily direct, explicit systematic reading intervention lessons using SBRR models that are selected by school/district.

Participate in scheduled meeting to develop skills, share practices, assess progress and to address challenges pertaining to core area implementation.

Make instructional decisions that are based on data analysis.

Frequently monitor progress of student receiving intervention services, in order to adjust instructional practices and student grouping.

Communicate and collaborate with classroom teachers about alignment between classroom instruction and intervention.

Participate in the collection and entering of DIBELLS data during assigned benchmark periods.

Collaborate with site-based teams to analyze and interpret assessment data to inform and drive instruction.

Attend appropriate trainings as assigned

Perform other duties that may be assigned by the Principal or Coordinator.
